ARTICLES OF INCORPORATION

OF

ODESSA NURSERY, INC.

The undersigned incorporator to these Articles of Incorporation hereby forms a under the laws of the State of Florida as follows:

ARTICLE I - NAME

The name of this corporation is ODESSA NURSERY, INC.

ARTICLE II - TERM OF EXISTENCE
