ARTICLES OF AMENDMENT ARTICLES OF INCORPORATION UNION PLANTERS INSURANCE AGENCY OF FLORIDA, INC.

I.

The name of the corporation, which was organized under Chapter 607 of the Florida Statutes, is "Union Planters Insurance Agency of Florida, Inc. d/b/a Union Planters Insurance Agency, Inc." (the "Corporation").
