**ARTICLES OF INCORPORATION  
OF  
INSTYLE HAIR & NAILS**

The undersigned incorporators to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

**Article I**  
**Name**

The name of the corporation shall be **INSTYLE HAIR & NAILS, INC.**  
9730 GENE STREET, HUDSON, FLORIDA 34669

**ARTICLE II**  
**NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is:

1. To own and operate a retail business.
2. To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wears and merchandise, real and personal property, and services of every class, kind and description.
3. To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses, in the State of Florida and all the other states and countries.
4. To contract debts and borrow money, issue and sell or pledge, bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of the corporate indebtedness as required.
5. To purchase the corporate assets of any other corporation and engage in the same or other character of business.
6. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any binds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership.
7. To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE III**  
**CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 5,000 shares of common stock having a nominal or par value of \$1.00 per share. The share holders of common stock shall have preemptive rights to acquire unissued or treasury shares of the corporation.

**ARTICLE IV**  
**TERM OF EXISTENCE**

This corporation shall exist perpetually.

**ARTICLE V**  
**REGISTERED AGENT**

The initial registered agent of this corporation shall be EUGENIA R DOWDY, whose business address is 9730 GENE ST, Hudson, Florida 34669. The street address of the registered office is 9730 GENE ST, Hudson, Florida 34669. The Board of directors may from time to time move the registered office to any other address in Florida.

**ARTICLE VI**  
**DIRECTORS**

This corporation shall have two directors initially. The number of directors may be increased or decreased from time to time by bylaws adopted by the stockholders.


