ARTICLES OF INCORPORATION OF INSTYLE HAIR & NAILS

The undersigned incorporators to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

Article I Name

The name of the corporation shall be INSTYLE HAIR & NAILS, INC. 9730 GENE STREET, HUDSON, FLORIDA 34669

ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

- 1. To own and operate a retail business.
- 2. To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wears and merchandise, real and personal property, and services of every class, kind and description.
- To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses, in the State of Florida and all the other states and countries.

- 5. To purchase the corporate assets of any other corporation and engage in the same or other character of business.
- 6. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any binds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership.
- 7. To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at ant one time is 5,000 shares of common stock having a nominal or par value of \$1.00 per share. The share holders of common stock shall have preemptive rights to acquire unissued or treasury shares of the corporation.

This corporation shall exist perpetually.
