The undersigned, for the purposes of forming a Corporation for Profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation for such corporation:

Article I - Name

The name of the Corporation is SAAVA INC.

Article II - Principal Office

The principal office of the Corporation is 17611 Lake Park Road, Boca Raton, Florida 33487.

Article III - Duration

The Corporation shall have perpetual existence unless dissolved pursuant to law.

Article IV - Nature of Business

The Corporation may engage in any activity or business permitted under the laws of the United States or the State of Florida.

Article V - Capital Stock

The Corporation is authorized to issue One Hundred (100) shares of One dollar (\$1.00) per share par value common stock.

Article VI - Initial Registered Office and Agent


