ARTICLES OF INCORPORATION OF EYE-4-EYE, INC.

I, the undersigned, hereby make, subscribe, acknowledge, and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

IDENTIFICATION

The name of this corporation is EYE-4-EYE, INC., having a principal place of business at 9068 Biscayne Boulevard, Miami Shores, Florida 33138.

1.
