NAME

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual, and shall be deemed to have commenced its existence on the 26th day of March, 1997.

ARTICLE THREE
PURPOSE

The purposes for which the corporation is organized are:

- b. To establish and maintain offices for any and all operations of this corporation at such places to be determined by the directors, wheresoever the same may be located.

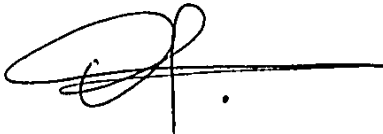

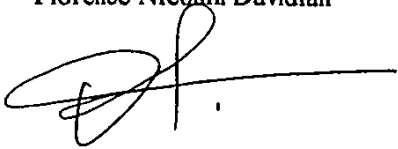


**ARTICLE EIGHT

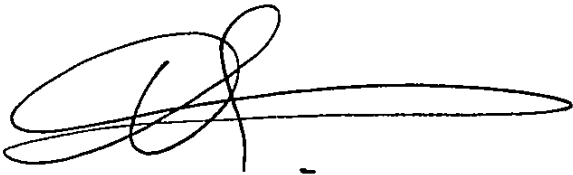

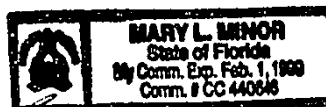
