The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME AND PRINCIPAL OFFICE

ARTICLE II - DURATION

This corporation shall commence its existence upon receipt of these articles by the Secretary of State.
