The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

# **ARTICLE I - NAME**

The corporate name for the corporation (hereinafter called the "corporation") is AccuStaff Licensing Corporation.

# **ARTICLE II - PRINCIPAL OFFICE**
