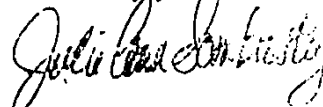

ARTICLE I
Name

The name of the corporation is SOARING TO NEW HEIGHTS, INC.

ARTICLE II
Duration

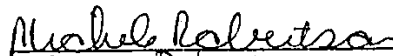

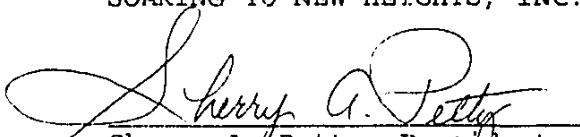

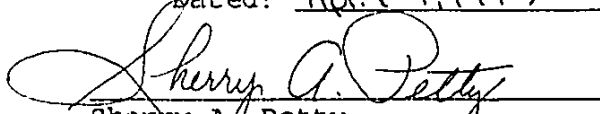
