ARTICLE I - NAME

The name of the corporation is Charles Hurst, Inc. (hereinafter called the "Corporation").

The mailing address of the Corporation is 310 Lakeshore Drive, Apartment #3, Lake Park, Florida 33403.

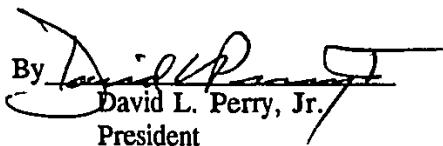

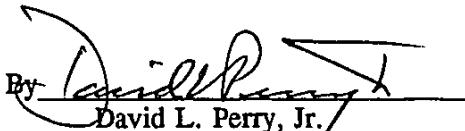
