ARTICLES OF INCORPORATION
OF

ASCOT ASSOCIATES, INC.

ARTICLE I. NAME

The name of this corporation is ASCOT ASSOCIATES, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. CAPITOL STOCK

This corporation is authorized to issue 10,000 shares of \$.01 par value common stock, which shall be designated "common shares".





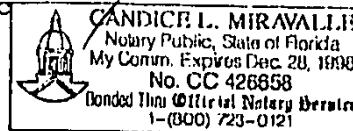
