The undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as follows.

ARTICLE I

NAME

The name of this corporation is: 2 MIL IMP. & EXP., INC.
