ARTICLES OF INCORPORATION
OF
GHOST DANCE MARINE, INC.

ARTICLE I - NAME

The name of this corporation is: Ghost Dance Marine, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

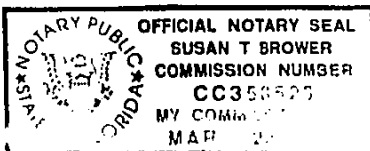
