

OF
THREE BLONDE MICE, INC.**

**ARTICLE I
NAME; PRINCIPAL OFFICE**

The name of this corporation is THREE BLONDE MICE, INC. (hereinafter referred to as the "Corporation"). The principal office and mailing address of the Corporation shall be located at 717 East Washington Street, Orlando, Florida 32801.

**ARTICLE II
DURATION**

The Corporation shall have perpetual existence commencing on the date of filing these Articles with the Department of State.

**ARTICLE III
PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as it now exists or may hereafter be amended.

**ARTICLE IV
CAPITAL STOCK**

The Corporation is authorized to issue One Thousand (1,000) shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

**ARTICLE V
PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of the Corporation, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the same price at which it is offered to others.

**ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of the Corporation is located at One North Rosalind Avenue, Suite 201, in the City of Orlando, Orange County, Florida 32801, and the name of the initial registered agent of the Corporation at that address is Richard Spice Wheeler, Esq.

**ARTICLE VII
INCORPORATOR**

The name and address of the Incorporator signing these Articles is Richard Spice Wheeler, Esq., whose address is One North Rosalind Avenue, Suite 201, Orlando, Florida 32801.


**ARTICLE IX
INDEMNIFICATION**

The Corporation shall indemnify any officer, director or employee (or any former officer, director or employee) of the Corporation to the fullest extent permitted by law.

**ARTICLE X
AMENDMENT**

The Corporation reserves the right to amend or repeal any provision of these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.






