The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following **Articles of Incorporation**:

**ARTICLE ONE (1)**

**NAME**

The name of the corporation is **MULTIMEDIA TECHNOLOGIES, INC.**

**ARTICLE TWO (2)**

**CORPORATE DURATION**

The duration of the corporation is perpetual.

**ARTICLE THREE (3)**

**PURPOSE OR PURPOSES**

The general purposes for which the corporation is organized are:

1. To engage in the business of installation of Data, Audio, Video and Fiber Optics Cabling, Consultation and Hardware.
2. To engage in any other trade or business which can, in the opinion of the **Board of Directors** of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
4. To do such other business as allowed and permitted under the laws of the State of Florida.

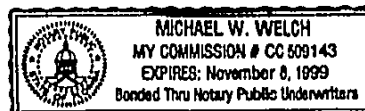
