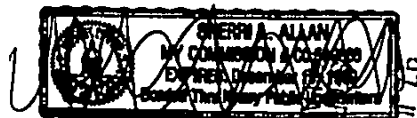

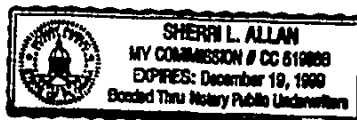

WHEREAS, the Corporation has not issued any shares;

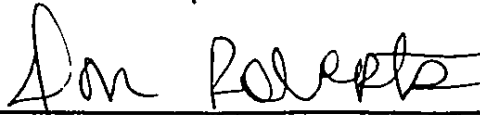
RESOLVED, that the Corporation be dissolved.
