**ARTICLES OF INCORPORATION  
OF  
FLORIDA NATURAL PONDS & LANDSCAPES, INC.**

THE UNDERSIGNED, acting as sole incorporator of Florida Natural Ponds & Landscapes, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name and Office**

The name of the corporation shall be Florida Natural Ponds & Landscapes, Inc., and the corporate address shall be 1238 Whirlaway Lane, Chuluota, FL 32766.

**ARTICLE II**

**Duration**

The duration of the corporation is perpetual.

**ARTICLE III**

**General Purposes**

The purpose of the corporation is to engage in any acts or activities for which a corporation may be organized under Chapter 607 of the Florida Statutes.

**ARTICLE IV**

**Shares**

The aggregate number of shares which the corporation shall have authority to issue is Five Thousand (5000) consisting of a single class of common stock, \$1.00 par value per share.

**ARTICLE V**

**Initial Registered Office and Agent**

**ARTICLE VI**

**Initial Board of Directors**
