# ARTICLE III

DURATION

This Corporation is created at peretuity, with profitable business objectives.

# ARTICLE IV

# OBJECTIVES OF THIS CORPORATION

To carry on the business of engaging in all phases of Import and Export

To assist firms and government entities in the programming, excution and financing of development programs.

To form groups of joint ventures and to arrange turn-key delivery programs for new plants and construction.

To assist banks, financial institution and government entities in making special arrangements to obtain medium and long term loan capitais.

To carry on the business of lending leasing of capital equipments, ships and aircrafts.

To carry on the business of financing of exports whether on straight line of credit or in leasing form! Specializing in turn-key industrial plants, ships, and aircrafts.
