Article I. Name: The name of this corporation is QUI SI SANA CORPORATION.

Article II. Duration: This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

Article III. Purpose: This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

Article IV. Capital Stock: This corporation is authorized to issue twenty shares of Class A voting stock at the par value of \$5.00 per share and one thousand shares of non-voting Stock at the par value of One Dollar (\$1.00) per share.
