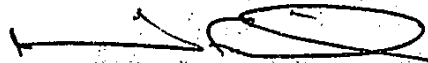

The undersigned does hereby subscribe to , acknowledge and file the following articles of incorporation for the purpose of creating a corporation under the law of the state of Florida.

**ARTICLE I - NAME**

The name of this corporation shall be: **ALPHA INTERNATIONAL CONSTRUCTION ,INC.**

**ARTICLE II - PURPOSE**

This corporation may engage in any activity or business permitted under the laws of the United States and state of Florida.

**ARTICLE III- CAPITAL STOCK**

This corporation is authorized to issue 500 shares of \$ 1.00 per value common stock, which shall be designated as "common shares" All of said stock shall be payable in cash , property ( real or personal labor or services in lieu there of at a just valuation to be fixed by the board of directors.
