ARTICLES OF INCORPORATION OF SIKA FINANCE COMPANY, INC.

ARTICLE I. NAME

The name of this corporation is:

SIKA FINANCE COMPANY, INC.

ARTICLE II. PURPOSE

This corporation is organized for the purpose of engaging in any or all lawful business for which under the laws of Florida.

ARTICLE III. POWERS

- a. To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed or in any other manner reproduced.
- b. To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with real or personal property or any interest therein, wherever situated.
- c. To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.
