ARTICLE I

NAME

The name of the corporation is CAPTIAL MARYLAND MARKETING CORPORATION.

ARTICLE II

DURATION

This corporation shall have a perpetual existence commencing upon filing of the Articles of Incorporation with the Secretary of State.

ARTICLE III

PURPOSE
