ARTICLES OF INCORPORATION

OF

REALLY NEAT CONTRACTING SERVICES, INC.

The undersigned subscriber to these Articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be REALLY NEAT CONTRACTING SERVICES, INC.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and this State.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Thousand (100) shares of Common Stock with a par value of \$1.00 per share.
