ARTICLES OF INCORPORATION FOR 2 NATURAL, INC.

97 APR FILED SECRETARY OF STATE ALLAHASSEE, FLORIDA

This undersigned, a natural person, and duly licensed to sell cosmetics in the State of Florida, does hereby form a corporation under the Florida Professional Services Corporation Act and other laws of the State of Florida.

ARTICLE ONE

The name of the Corporation is 2 NATURAL, INC.

ARTICLE TWO

The purpose for which the Corporation is organized is to sell cosmetics. Subject to the laws of the State of Florida regarding Professional Corporations, the Corporation may engage in any and all activites and business permitted under the laws of the United States and of the State of Florida. The Corporation shall have all of the powers vested in a Professional Corporation organized under and existing by virtue of the laws of the State of Florida.

ARTICLE THREE

The maximum number of shares of stock which the Corporation is authorized to issue and have at any time is 100 shares of common stock having a par value of \$1.00 per share.


