ARTICLES OF INCORPORATION

OF

RKR ENTERPRISES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is RKR ENTERPRISES, INC.

ARTICLE II - DURATION

The duration of the Corporation shall be perpetual.

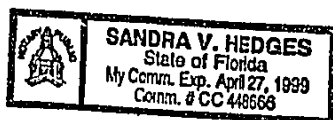

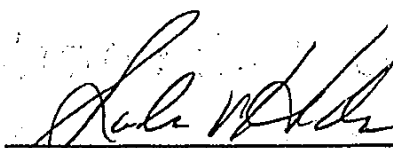

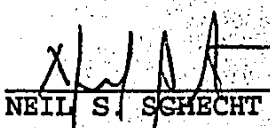
