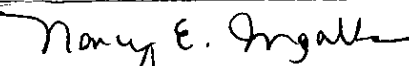

This letter is in reference to the above named corporation. An annual report was last filed for this corporation in May 1998. In 1999, the taxpayer moved from the address shown above to 3500 Marigold Court, #216, Palm Beach Gardens, FL. For some reason, the annual report form was not forwarded to the new address. While the corporation itself was not conducting business activity, it was intended to keep the corporation open. The taxpayer did not intentionally ignore filing the annual report, but was simply unaware of the filing requirement and did not receive a form. The absence of filing the report was unintentional on the part of the taxpayer. The shareholder intends to conduct a small amount of business and would like to conduct this business through this corporation. The reinstatement fees would put an undue financial burden on the shareholder. We are requesting an abatement of the reinstatement fee. The taxpayer would be able to pay the annual report fees for the years that the corporation was administratively dissolved.
