ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following EFFECTIVE DA articles of incorporation:

ARTICLE ONE

The name of the corporation is DASIS LIQUOR OF ORLANDO. INC.

ARTICLE TWO

This corporation shall commence existence as of the date of execution of these Articles. The terms of existence shall be perpetual.
