The undersigned incorporator, for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is:

The Corporation will indemnify Bruno Lucidi and anyone who enters into a contract on behalf of this corporation as long as the contract has been approved by the Board of Directors.






