ARTICLE I

NAME, PRINCIPAL OFFICE, AND MAILING ADDRESS

The name of this corporation is Moore & Young, Incorporated. The corporation's initial principal office and mailing address are located at 2624 Oak Street, Jacksonville, Florida 32204.

ARTICLE II

NATURE OF BUSINESS

This corporation is organized for the purpose of engaging in and transacting any or all lawful business permitted under the laws of the State of Florida or any other state and of the United States.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue Seventy Five Hundred (7500) shares of common stock having a par value of One and No/100 Dollars (\$1.00) per share,

which shares shall be and hereby are designated as "Common Shares" which shall consist of One Hundred (100) shares of voting common stock.

ARTICLE IV

TERM OF EXISTENCE

The term for which this corporation shall exist shall be perpetual, commencing on May 1, 1997.

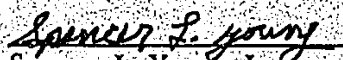
AMENDMENTS
