The undersigned Incorporators, for the purpose of forming a Corporation for profit under Chapter 607, Florida Statutes, adopt the following Articles of Incorporation.

ARTICLE I
"NAME"

The name of the Corporation is SHOOTERS' BILLIARDS OF SANFORD, INC.

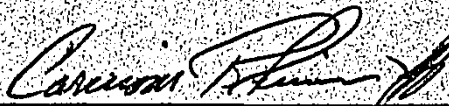
ARTICLE VIII

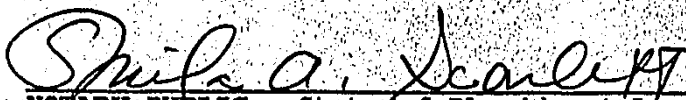
