ARTICLE ONE - NAME

The name of the corporation is GUGINO ENTERPRISES, INC.

ARTICLE TEN - INDEMNIFICATION

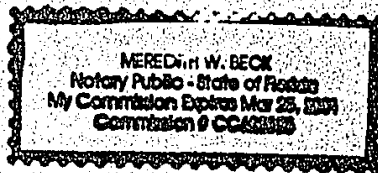
