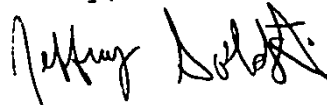

ARTICLE II.

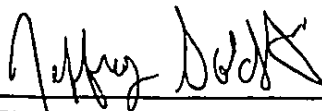
The name and address of each of the director of the Corporation remains unchanged.

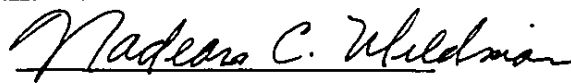
