The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is:

ARTICLE II. NATURE OF BUSINESS

The general nature of this business shall be the general practice of the profession of Attorney at Law and the rendering of Professional Legal Services in connection therewith. In addition thereto, the corporation may do such things as permitted by law, including but not limited to investing in real estate, mortgages, stocks, bonds or any other type of investments of any kind, nature or description.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED (100) SHARES of Common Stock without nominal or par value. All of said stock shall be payable in cash, property,

This corporation shall commence upon the date of filing with the Secretary of State.

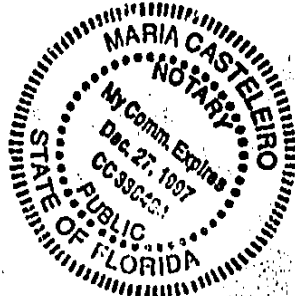
