This Corporation is to exist perpetually.

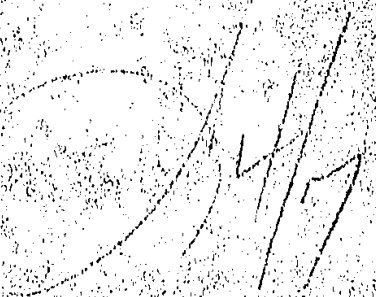
ARTICLE III - PURPOSE
