The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

**ARTICLE ONE**

The name of the corporation is **SWANN & ASSOCIATES SALES, INC.**

**ARTICLE TWO**

The corporation may engage in any and all lawful businesses for which corporations may be incorporated under Chapter 607, Fla. Stat.

**ARTICLE THREE**




