**ARTICLES OF INCORPORATION
OF
PAXSON COMMUNICATIONS OF FRESNO-61, INC.**

The undersigned, acting as incorporator of PAXSON COMMUNICATIONS OF FRESNO-61, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII. INITIAL BOARD OF DIRECTORS


ARTICLE IX. BYLAWS


