

ARTICLE ONE

The name of the corporation is **WILD WEST GUNSLINGERS, INC.** The principal address of the corporation is: 1651 S.W. 127 Avenue, Davie, Florida 33325.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**


ARTICLE FIVE
