

# Articles of Incorporation of

## ARTICLE ONE

The name of the corporation is SHELBY RACING OF FLORIDA, INC. The principal address of the corporation is: 1300 W. McNab Road, Ft. Lauderdale, Florida 33309.

## ARTICLE TWO

The period of its duration is perpetual.

## ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

## ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is 100, at \$1.00 par value.

## ARTICLE FIVE
