

**ARTICLES OF INCORPORATION
SOUTH

ARTICLE I - NAME

The name of this corporation is Mahavir^{South} Florida, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.


