# ARTICLES OF INCORPORATION OF LEFT OF CENTER, INC.

#### ARTICLE I - NAME

The name of this corporation is LEFT OF CENTER, INC.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

#### ARTICLE IV - CAPITAL STOCK

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

#### ARTICLE XIII - SHAREHOLDER OUORUM AND VOTING

#### ARTICLE XIV - MANAGEMENT OF CORPORATION BY DIRECTORS

The Directors of this corporation may take action by written consent, as provided by law.

Dividends may be paid to shareholders (only out of the unreserved and unrestricted earned surplus of the corporation). Dividends payable in shares of any class may be paid to the holders of shares of any other class.

#### ARTICLE XXI - AMENDMENT

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
