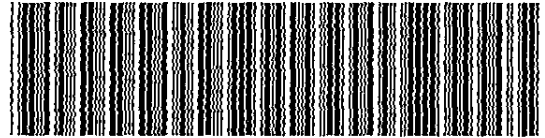

Name: The name of the corporation is **TECHNOLOGY DESIGN GROUP OF FLORIDA, INC.**

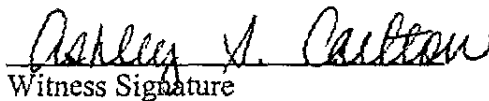
The principal place of business of this corporation is 4532 Barracuda Drive, Bradenton, Fl 34208.

2. The aforesaid amendment was unanimously adopted by all of the shareholders and directors on the 1<sup>st</sup> day of May, 2003.

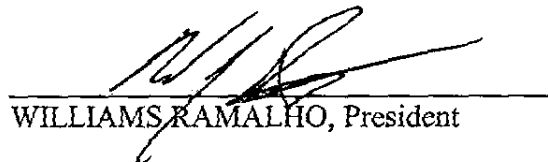
