

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST:** The name of the corporation is G-FORCE THRILL RIDES, INC.
- SECOND:** The period of its duration is perpetual
- THIRD:** The purpose(s) for which the corporation is organized are development of entertainment rides for the public and possible manufacture of said rides as well as operating entertainment rides throughout the country and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
- FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 1,000 of shares of common stock having no par value or amount of par value each.
- FIFTH:** The corporation will not commence business until at least One hundred Dollars (\$100.00) have been received by it as consideration for the issuance of shares.
