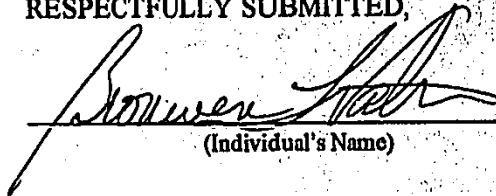

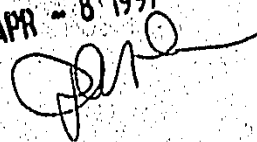

ARTICLE I NAME

The name of the corporation shall be OUTCOMES ANALYSIS CORPORATION.

ARTICLE II PURPOSE
