ARTICLES OF INCORPORATION OF

A-1 FORMAL WEAR, INC.

I, THE UNDERSIGNED, do hereby associate myself together for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

ARTICLE I - NAME

The name of the Corporation shall be: A-1 FORMAL WEAR, INC., a Florida Corporation.

ARTICLE II - PURPOSE

- A. To carry on, perform and engage in the business of the sale, purchase, rental, and alteration of all types of tuxedos, men's formal wear, men's clothing and all accessories thereto and to perform all other acts which may be necessary.
- B. To carry on and engage in any business or activity which may be authorized and permitted under and by virtue of the laws of the United States of America or the State of Florida.

ARTICLE III- CAPITAL STOCK

The Corporation shall be authorized to issue capital stock in the following manner, to wit: FIFTY(50) Shares of Common Stock, having no par value.

ARTICLE IV - POWERS
