ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ANDRESS & ANDRESS, INC.

Pursuant to the provisions of Section 67.1006, Florida Statutes, the undersigned Florida rest for profit corporation adopts the following Articles of Amendment to its Articles of Incorporation, filed April 8, 1997.

FIRST: The present name of the corporation is **ANDRESS & ANDRESS, INC.**. That the following amendment of the Articles of Incorporation were adopted by the corporation:

Article 1 of the Articles of Incorporation is changed to read:

ARTICLE 1

Name
