

# ARTICLES OF INCORPORATION OF

# E-Z BUY HOME MARKETING, INC. SA-RATOGA, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE ONE

## NAME

The name of the Corporation is E-ZBUY HOME MARKETING, INC... SARATO GA, INC...

## ARTICLE TWO

#### PRINCIPAL OFFICE

The address of the initial principal place of business of the Corporation is 400 South Park Road, #102, Hollywood, Florida 33021. The mailing address of the corporation is the same.

#### ARTICLE THREE

## CAPITAL STOCK

The number of shares of stock that the Corporation is authorized to have outstanding at any one time is onethousand (1,000) shares, all of which shall be common shares with a par value of one (\$1.00) dollar. The Board of Directors may determine the preferences, limitations and relative rights (within the limits set forth in the Florida Business Corporation Act) of:

- 1. Any class of shares before the issuance of any shares of that class, or
- 2. One or more series within a class before the issuance of any shares of that series.

Each series of a class must be given a distinguishing designation. All shares of a series must have preferences, limitations, and relative rights identical with those of other shares of the same series and, except to the extent otherwise provided in the description of the series, of those of other series of the same class. Before issuing any shares of a class or series created under this section, the corporation must deliver to the Department of State for filing Articles of Amendment, which are effective without shareholder action, that set forth:

1. The name of the corporation,

- The text of the amendment determining the terms of the class or series of shares;
- 3. The date the amendment was adopted; and
- A statement that the amendment was duly adopted by the Board of Directors.

## ARTICLE FOUR

## INITIAL REGISTERED AGENT AND ADDRESS

As set forth in the registered agent's written acceptance of his appointment, which is delivered to the Department of State with these Articles of Incorporation, the Corporation's initial registered office is located at 460 South Park Road, #102, Hollywood, Florida 33021. The Corporation's initial registered agent at that office is Chris Henry.

#### ARTICLE FIVE

## **PURPOSE**

The purposes for which the Corporation is organized are to own and operate a real estate marketing operation which it deems appropriate and any and all other lawful businesses within the State of Florida.

## **DURATION**

The term of existence of the Corporation is perpetual.
