The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The initial street address of the principal office of this corporation is to be at 5861 SW 147 CT., Miami, FL. 33193


The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.
