The undersigned, being sui juris, and desiring to form a corporation for profit under the Laws of the State of Florida, does hereby subscribe to these Articles of Incorporation.

ARTICLE I

The name of the corporation is:

ARTICLE II

The principal purpose for which this corporation is formed is to engage in the operation of a freight forwarding business and all other lawful business, act or activity for which corporations may be organized.

ARTICLE III

The maximum number of shares that this corporation is authorized to have outstanding at any time is ONE HUNDRED SHARES (100) of common stock, having a par value of FIVE DOLLARS (\$5.00) per share.

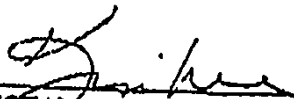
