ARTICLES OF INCORPORATION

OF

G & P GROUP, INC.

I/WE, the undersigned, do hereby associate ourselves together and subscribe these

Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, Chapter 607 and subject to the following provisions:

ARTICLE ONE

The name of the corporation shall be: G & P GROUP, INC.

ARTICLE TWO

This corporation shall have perpetual existence and may engage in any activity of business permitted under the laws of the United States and of the State of Florida.

The general nature of the business to be transacted by this corporation shall be:

- a) Cigar distribution and wholesale.
